The First meeting of the 2008-2009 academic year was called to order by Chair L. Dabundo at 1:06 p.m.

L. Dabundo began the meeting with introductions, followed by **area updates**. **The resignation of OWL Radio's General Manager** was deliberated. After discussion a motion was made by J. Azriel to grant K. Schmidt, the station's Program Director, dual authority as GM and PD through the end of the fall '08 and revisit the situation at that time. J. Edens seconded. The motion passed 7-0-0.

J. Azriel gave the Board an update on the **SMB Alumni Representative position**. After discussion it was decided that A. Pascual and E. Bonza would collect and forward candidate names to the subcommittee for phone interviews and appointment.

The **vacancy with student membership** was discussed by E. Bonza. Candidates will be encouraged to attend the next meeting.

L. Dabundo brought up the **co-chair student position** vacancy. M. Yanovsky nominated herself. The nominations were put on hold until more of the student slots on the Board were filled.

The possibility of a **part-time professional position** to assist and lend consistency to OWL Radio was raised by J. Azriel and E. Bonza. J. Ratchford recommended seeking funding support before requesting approval for the position.

L. Dabundo asked the Board to review their schedules for the next meeting. After discussion, the second meeting of the SMB was scheduled for **Thursday, October 16, 12:30 p.m.** E. Bonza will determine the location and forward it to members.

The meeting was adjourned at 2:45 p.m.
